Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Project Based Vouchers

The Boise City Housing Authority will operate a project-based voucher program using up to 20 percent of its budget authority for project-based assistance. BCHA intends to offer vouchers competitively to entities building new, rehabbing existing structures. This strategy will assist in creating mixed income communities. The BCHA will also accept proposals for PBV assistance from owners that were competitively selected under another federal, state or local housing assistance program, including projects that were competitively awarded Low-Income Housing Tax Credits on an ongoing basis. It is the BCHA's goal to select sites for PBV housing that provide for deconcentrating poverty and expanding housing and economic opportunities.

The changes to BCHA policies and procedures are addressed in the Housing Choice Voucher Administrative Plan and the Admissions and Continued Occupancy Policy (ACOP) which are out for review and public comment with this plan.

B.3 Progress Report.

Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan.

The goal of the Boise City Housing Authority (BCHA) is to assist the most needy and vulnerable households in the City of Boise such as those households that pay a disproportionate share of their income on rent. The Housing Choice Voucher (HCV) Program aims to provide affordable housing to existing very low income households. The HCV program allows the BCHA to use existing units in the private rental market and make them affordable to very low income households. The BCHA has a commitment to the highest level of service to assist the greatest number of people possible while staying within the available funding. It is the policy of the BCHA to achieve and maintain full lease-up of all vouchers. The HCV Program is designed to achieve the following major objectives:

1. To provide affordable rental housing that is decent, safe, and sanitary to existing, very low income households.
2. To ensure that all units in the program meet Housing Quality Standards and that tenant's pay fair and reasonable rents.
3. To promote fair housing and the opportunity for very low income households of all ethnic backgrounds to experience freedom of housing choice.
4. To promote a housing program with maintains quality service and integrity which encourages private property owners to rent to very low income households.

With the funding received, the BCHA administers a program that continues to meet the objectives and goals outlined above.

The Housing Choice Voucher Program opened its waiting list May 9, 2016 through May 27, 2016 using an online lottery based system. Due to limited funding availability, the BCHA only opened the waiting list to applicants that met the following criteria:

- Head of Household must be over 18 years of age; AND
- The household must be low-income (50% or below Area Median Income); AND
- Must meet at least one of the following definitions;
 1. Head of household, co-head or spouse are age 62 or older; or
 2. Head of household, co-head or spouse is disabled; or
 3. Families with children under the age of 18

The BCHA conducted a Physical Needs Assessment (PNA) and Energy Audit for its Public Housing Program to determine repairs and prepare for the REAC inspections.

The PNA enables the BCHA to better assess the capital needs of our Public Housing Hi-rise buildings and to facilitate capitol planning and to allow the BCHA to take advantage of capital improvement opportunities.

The Energy Audit enables the BCHA in their capital funds planning to maximize energy conservation and efficiency measures to preserve their housing.

Responses to the collection of information are required to obtain a benefit or to retain a benefit. The information requested does not lend itself to confidentiality.
